PRODUCTS: PRICES and FEATURES

Unless otherwise indicated, the prices of the published products must be understood as inclusive of VAT at 22%. The prices of the products published from time to time replace the previous ones and are subject to the actual availability of the products. Litiotech reserves the right to confirm or modify the prices of the products published on its website or in information brochures and advertising material, upon confirmation of the customer's order. The products are not provided on trial. Although the operators provide information on the characteristics of the products, the customer is responsible for choosing the products ordered.

ORDERS - BILLING

Before ordering any product, please check dimensions, connections and characteristics.

All purchase orders must be complete in all their parts and must contain all the elements necessary for the correct identification of the products ordered.

Each product order sent to Litiotech constitutes the customer's contractual proposal and, therefore, will be binding for Litiotech only if confirmed by it for acceptance. The fulfillment of the order by the company Litiotech is equivalent to confirmation and acceptance of the same.

Litiotech reserves the right not to accept incomplete orders. In case of non-execution of the order, if the same is due to the unavailability of the products ordered by the customer, Litiotech will inform the customer as soon as possible, reimbursing any sums already paid by them for the supply not performed. In this case, the customer will not be entitled to any reimbursement or indemnity or compensation of any kind.
